

Origin Lounge Contest Rules

1. The promoter is Time Inc. (UK) Ltd, whose registered office is at Blue Fin Building, 110 Southwark Street, London, SE1 0SU (the "**Promoter**"). The Administrator is Vision Critical Communications Inc., with a business address at 17 Hatfield, 2nd Floor, London, SE1 8DJ (the "**Administrator**").
2. The contests are open to entrants aged 18 or over resident in the United Kingdom, Channel Islands, and Isle of Man, excluding employees and past employees (and their families) of the Promoter, the Administrator, their printers and agents, the suppliers of the prizes and anyone materially connected to the administration of the contests.
3. There is no entry fee and no purchase necessary to enter prize draws and competitions offered by the Promoter (the "**Contests**") from this website (<http://www.theoriginlounge.co.uk>) (the "**Website**").
4. Proof of identity and age may be required upon request by the Promoter and/or the Administrator.
5. Use of a false name or address will result in disqualification.
6. All entries must be made directly by the person entering the Contests.
7. The Contests period opens at 0:00 GMT on 1 April 2014 and ends at 23:59 PM GMT on 31 December 2016 (the "**Contest Period**"). Contests will be conducted each month during the Contest Period. Each Contest will be held on or within ten (10) business days of the last day of the previous month in the Contest Period (each a "**Contest Date**"). Entries received after the last day of the applicable month in the Contest Period will not be accepted.
8. To be eligible for:
 - (i) the Monthly Prizes (as defined below), entrants ("**Entrant**") must complete an online survey available on the Website. All completed online surveys will be eligible and will be entered into one prize draw in a month during the Contest Period.
 - (ii) the Forum Prizes (as defined below), Entrants must post in an online discussion forum on the Website in that month;
 - (iii) the Bespoke Forum Prizes (as defined below), Entrants must be female, between the ages of 40-60 (inclusive), join Ynot!Talk and post in the bespoke forum on the Website in that month.

15. Draws and winner notification:

- (i) Monthly Prizes: On each Contest Date, the winner(s) will be selected at random by an independent panel of judges from all correct and eligible entries received.
- (ii) Forum Prizes and Bespoke Forum Prizes: On each Contest Date, the winners(s) will be selected from the best forum posts, by an independent panel of judges from all the eligible entries received.

All winner(s) will be notified in writing to the email address they provided to the Website within fifteen (15) days of the applicable Draw Date.

16. The decision of the judges is final and no correspondence will be entered into over this decision.

17. Re-draws: The Promoter and the Administrator are not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify the winner. If a selected Entrant cannot be contacted or fails to respond within the allotted time, the Promoter and Administrator reserve the right to void that entry and select another eligible Entrant for that prize (and in the event that the subsequent selected Entrant cannot be contacted or fails to respond, a further Entrant will be selected, until a winner is determined, provided further that in the event that a winner is not determined after attempts have been made to contact a total of three (3) Entrants, the Promoter and Administrator may elect not to conduct any further redraws and not award such prize).

Confirmation of winner: All winner(s) notified will be required to complete, and return to the Administrator a web-based winner notification survey ("**Winner Notification Survey**") within five (5) days of receipt. If a selected Entrant(s) fails to complete, and return the Winner Notification Survey to the Administrator within five (5) business days, the Administrator reserves the right to void that entry and select another eligible Entrant for that prize.

19. The Prize will be dispatched by the Promoter or the Administrator via post within 6 weeks of the winner providing the Promoter or the Administrator with their Winner Notification Survey.

20. TIUK accept no responsibility for entries unsuccessfully submitted to the Website.

21. Failure to respond and/or provide an address for delivery, or failure to meet the eligibility requirements may result in forfeiture of the prize.

The Promoter or the Administrator each reserve the right to cancel any Contests or amend these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the Promoter's or Administrator's control or at any other time. 25. In the event that the prize offered is unavailable due to circumstances beyond our control, the Promoter and the Administrator reserve the right to offer an alternative prize of equal or greater value.

26. All Entrants to the Contests will be deemed to have accepted and agree to be bound by these terms and conditions.

27. In the event of a discrepancy between these terms and conditions and the details in the promotional material, the details in these terms and conditions shall prevail.

By entering, participants release and hold harmless the Promoter, the Administrator, its parents, subsidiaries, affiliates, directors, officers, employees and agents from any and all liability and any injuries, loss or damage of any kind arising from or in connection with this promotion to the extent permitted by law.
